RIDE-ALONG PROGRAM

INSTRUCTIONS FOR OBSERVER

1. Observer will be under the complete control of the Deputy Sheriff at all times. If a dangerous or emergency situation arises, the deputy may direct observer to take appropriate actions to ensure their safety. Observer shall follow the directions of the deputy. The deputy may, at any time, discharge an observer if he feels the observer's presence would constitute a hazard to the observer or citizenry or interfere with the proper performance of his duties.
2. Observer will remain in the radio car at the scene of police activities unless otherwise instructed or permission is given by the deputy.
3. Observer is not to participate in police activities unless specifically requested by the deputy or the deputy's immediate supervisor.
4. Observer is not to engage in any conversation with prisoners, suspects, witnesses, or any other parties contacted by the deputy in the course of business unless requested by the deputy.
5. Observer shall not interfere verbally or physically at any time during the deputy's activities. You are encouraged to seek information regarding procedures and activities, but all questions should be asked at an appropriate time.
6. Observer shall arrive at the Sheriff's Office 15 minutes prior to the assigned time. If, for some reason, an observer is unable to keep his appointment, he should notify this office as soon as possible.
7. Observer should wear suitable clothing which is neat and in good taste, such as slacks and sport shirt, or blouse. Don't forget to wear warm clothing in cold weather. Tape recorders or cameras will not be allowed; nor may the observer carry any object(s) that might be considered a weapon.
8. Observer is required to sign the *Agreement Assuming Risk of Injury or Damage, Waiver & Release of Claims and Indemnity Agreement* form (see Page 2 of this packet) in the presence of an authorized representative of the Sheriff's Office.
9. Observer will be required to keep all names and information confidential if such information could in any way jeopardize a citizen's reputation or community standing or if such information could cause a detrimental condition to public safety.
10. The Shift Commander has full authority to deny "Ride-Along" participation, at any time during or prior to the observer's participation if he feels it interferes with safety or efficiency of the Sheriff's Office operation due to any existing condition.
11. At the conclusion of the "Ride-Along", observer will be given a Evaluation Sheet (see Page 3 of this packet) and will be asked to complete it and return it to the Sheriff's Office.

AGREEMENT ASSUMING RISK OF INJURY OR DAMAGE, WAIVER & RELEASE OF CLAIMS AND INDEMNITY AGREEMENT

I, _____, am under/over the age of 18 and not a member of the Mendocino County Sheriff's Office. I have made a request for permission to ride in an assigned vehicle and to accompany a member of the Sheriff's Office during the performance of their official duties.

The County of Mendocino, through its Sheriff's Office, is willing to allow me to ride as a guest in an assigned vehicle and to accompany a member of the Sheriff's Office during the performance of their duties, only if I agree to the following conditions:

1. That I am aware the work of the Sheriff's Office is inherently dangerous and that I may be subject to the risk of death or personal injury or damage to my person or property by accompanying a member of the Sheriff's Office during the performance of their official duties. I freely, voluntarily, and with such knowledge assume the risk of death, personal injury, or property damage, incurred in any way whatsoever while accompanying a member of the Sheriff's Office during the performance of their official duties.

2. That I, or my heirs, executors, administrators and assigns, will defend and indemnify the County of Mendocino, its officers, employees and agents, and each of them, against any and all manner of actions, causes or actions, suits, debts, claims, demands or damages or liability or expense of every kind and nature incurred or arising by reason of any actual or claimed negligent or wrongful act or omission of mine while riding in any vehicle assigned to the Mendocino County Sheriff's Office or while accompanying any member, or members, of said Sheriff's Office during the performance of their official duties.
